Market impact and portfolio regularization

Abstract

The problem of portfolio optimization in the presence of market impact is considered. The problem of finding the optimal portfolio under Expected Shortfall (ES) in the case of linear market impact is discussed in detail. Once market impact is taken into account, a regularized version of the usual optimization problem naturally emerges and it is shown how the market impact removes the instability of ES in this context.
